Our goal is to provide education to all of OPG Physicians and Advanced Practice Providers within Central Ohio and our regional facilities through:

- New Provider Onboarding
- General Group Education
- Provider Coding Quality Reviews
- Education Resulting from claim denials
- Education Resulting from VP, Director, Practice Manager or Compliance Requests
- Online coding resources, available through eSource OPG Provider Coding Education

## **OPG New Provider Onboarding**

- All new providers receive an onboarding coding education meeting with a Coding Education & Quality Analyst (CEQA) within 30 days of hire.
- Coding quality reviews will be performed at 30, 60 and possibly 90 day intervals with feedback.
- Coding Quality reviews will consist of 10 E/M chart review (5 new patients, 5 established patients) using weight-based scoring tool.
- 85% or greater accuracy standard
- Providers who score less than 85% will attend a virtual education meeting via Teams with a CEQA to review the results.
- Providers who score less than 85% on their 60 day review will receive a third review at 90 days.

## **OPG Coding Education**

- Topics include: Outpatient E/M, Hospital Based E/M, and Annual Wellness Visits
- Teams group education opportunities are offered for all providers. Email RevCycle\_Coding\_OPG\_CEQAs@ohiohealth.com to enroll.
  - 1 live session per month with rotating topics
  - 12-1 PM classes offered during provider lunch hour
  - CEQA will enroll provider and email confirmation of class and Teams link.
