#### **Christopher B. Colwell, MD, FACEP**

Christopher Colwell, MD, is the chief of Emergency Medicine at Zuckerberg San Francisco General Hospital and Trauma Center, San Francisco's only Level I trauma center, and a professor and vice chair in the department of Emergency Medicine at the University of California, San Francisco School of Medicine.

Dr. Colwell completed the Denver Health Residency in Emergency Medicine in 1996 (formerly Denver General Hospital), and worked at the University of Michigan from 1996 to 1998 before accepting a job as the associate medical director of Emergency Medical Services at Denver Health in July 1998. He was promoted to medical director of the Denver Health Paramedic Division, Denver 911 Emergency Communications Center and Denver Fire Department in 2000. Dr. Colwell served in that role for 10 years before taking over as chief of Emergency Medicine at Denver Health in 2009.

Dr. Colwell was the physician at the scene for the Columbine High School shootings and treated victims of the Aurora Theater shooting in the emergency department. He writes and speaks nationally on the topics of trauma, EMS issues, disaster planning and mass casualty incident management.



## Marcus Engel, MS, CPXP, CSP

Marcus Engel, MS, CPXP, CSP, is a certified speaking professional and author whose messages provide strategies for excellent patient care. As a college freshman, he was blinded and nearly killed after being struck by a drunk driver. Through two years of rehabilitation and more than 350 hours of reconstructive facial surgeries, Mr. Engel has witnessed the good, the bad, and the profound aspects of patient care.

Mr. Engel's keynote presentation, The Other End of the Stethoscope, has been heard by thousands of healthcare professionals, and his four books are used in scores of nursing and allied health programs to teach the basic foundations of caregiving. He is currently working on a fifth book based on his experiences in the healthcare system.

Mr. Engel is also an adjunct professor at the University of Notre Dame, where he teaches pre-med students the art of "being with." Mr. Engel completed his bachelor's degree in sociology from Missouri State University and his master's degree in narrative medicine from Columbia University. He was awarded an honorary doctorate from the Philadelphia College of Osteopathic Medicine.

Mr. Engel lives in Orlando, Florida with his wife, Marvelyne, and his Seeing Eye dog, Elliott. He is, in his words, a social media junkie and loves to connect with healthcare professionals nationwide. All social media information can be found at MarcusEngel.com.
