Significant advances have been made in the treatment and prevention of cardiovascular disease. 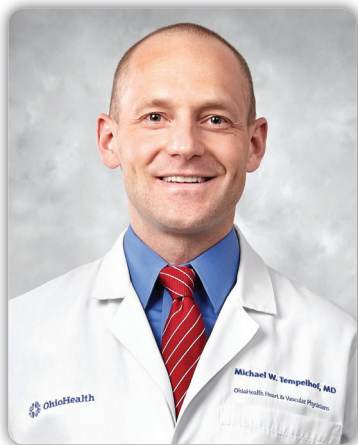
