Dr. Rath serves on the executive council and as co-chair of the Cervical cancer Screening work group for the Ohio Partnership for Cancer Control.

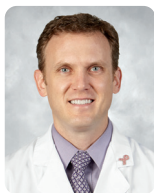


### **Genetic risk and Gynecologic malignancies: Approach to screening and management of high-risk patients**
